Consultancy service for Lead Facilitator for Province Level USAID Integrated Nutrition Co-creation

August—September 2024

Background

Helen Keller invites applications from individual/firms to facilitate province level co-creation of USAID Integrated Nutrition.

The primary goal of USAID Integrated Nutrition is to improve the nutrition status of women, adolescents, and children in Nepal's underserved and marginalized communities. This initiative will address the direct and underlying determinants of malnutrition in Nepal while strengthening the national and local enabling environment to implement multisectoral nutrition programs through four synergistic intermediate results. Success will be measured by improvements in nutrition status indicators among women of reproductive age, adolescents, and children. One of the crucial activities under this project is to undertake co-creation at different levels.

Scope of Work and Deliverables

The Lead Facilitator will work with the Helen Keller team in Kathmandu and the major tasks will include:

- Review nutrition literature published at national and global perspectives and priorities.
- Familiarize the key components of USAID Integrated Nutrition.
- Meet with Helen Keller team to finalize co-creation agenda, tools, and facilitation structure.
- Facilitating co-creation workshops in Madhesh, Lumbini, Karnali, and Sudurpaschim Provinces

Deliverables

The consultant shall accomplish the following deliverable during August—September 2024:

- Submit a work completion report with clear articulation of sector-wise priority of each province.

Administration and Logistics Management

Qualifications/Evaluation Criteria

- Masters's degree in any discipline, preferably in health and nutrition
- Demonstrated work experience of facilitating learning events for larger and diverse audience at province and federal level
- Familiar with multi-sectoral nutrition programming; specific and sensitive, health system strengthening, nutrition activity design and implementation -focusing on women, youth, and marginalized groups.
- Experience of engaging with province and federal level governmental and non-governmental stakeholders, private sectors and community representatives.
- Ability to facilitate sessions independently by engaging participants within in given format
- Ability to comprehend discussion notes quickly summarize.
- Excellent facilitation and workshop conduction skills in Nepali is essential and local language would be an asset.
- Excellent report writing skills.

The evaluation committee will review received CVs, and only shortlisted candidates will be invited for the interview process.
